# BOARD OF SUPERVISORS MEETING Monday, June 07, 2021 – 6:30 p.m.

#### **Meeting Minutes**

The Board of Supervisors of the Town of Osceola met for a regular monthly meeting Monday, June 7, 2021, at 6:3 p.m. at the Osceola Town Hall, Dresser, Wisconsin.

**CALL TO ORDER:** Chair Dale Lindh called the meeting to order at 6:31 p.m.

VERIFICATION OF MEETING POSTING: Interim Clerk Jan Carlson confirmed that the notice was posted at the Town Hall, Dresser Post Office, the First Community National Bank, the Town Web Site, and the Town Facebook page.

## PRESENTATION OF 2020 AUDIT REPORT BY CLIFTON LARSON ALLEN (CLA)

Clifton Larson Allen was represented by Brock Geyen and Sarah Kobs. They reported that the Town's fund balance as of December 2020 was \$182,376. Total Revenues for 2020 were \$915,409 and Expenditures were \$937,247. The Town Fund balance is at 19% and a recommendation to be 24-33%. It was also brought to the Board's attention material weaknesses in the management letter. The three weaknesses mentioned are: Limited Segregation of Duties, Internal Control over the Financial Reporting

Process and Material Audit Adjustments. These are weaknesses similar to other smaller government entities who have limited staff.

## MOTION BY EVERSON/ SECOND BY GUSTAFSON TO ACCEPT THE TOWN OF OSCEOLA'S 2020 AUDIT REPORT AS PRESENTED BY CLIFTON LARSON ALLEN. MOTION CARRIED.

#### **PUBLIC COMMENT:**

Chairman Lindh called for a half hour of public comments. Three (3) minutes were allotted for each speaker.

Cindy Thorman - expressed concerns of last-minute candidate(s) being submitted [nominated] for Town supervisor, recommending the Board use the process established whereby a resume was to be submitted by the due date specified.

Warren Johnson - commented on Eagle Bluff Road, nuisance properties, County zoning in regard to the Red Barn, getting the Plan Commission up and running and wished the five member board the best.

Denise Skjerven - commented on several agenda items: 13g she wanted an explanation of what is the Board of Review and asked if the 7/20 BOR meeting is open to the public. 13j she questioned the potential legal cost to the town, and how much would be covered by insurance. She had several questions regarding committees: taking nomination for committee positions, board setting parameters, would the chair sit on committees, would committee meetings be posted and open to the public, would there be a point person on each committee so Town constituents can ask questions to the committee, was the Media Committee going to encompass Technology, and legal questions, and would Town ordinances be updated. Then asked if the board packet can be posted or available before the Town meeting.

#### **PUBLIC WORKS REPORT:**

Tony Johnson, Public Works Supervisor spoke to the current road projects he had been working on. The Town has collected 33 tires and various pieces of furniture in the last couple of months, and removed 8 trees from Sand Lake property line next to the cemetery. He provided road counts and was working on the boat landing at Popular Lake and reported that the road construction projects are in progress.

#### TREASURER'S REPORT

Treasurer Carlson reviewed reports which were included in the Board packet. She noted that as of this date all items are current and reflect accurate balances. Cash balances as of June 6, 2021, are: General Fund \$37,456.83; Money Market Account \$297,458.50; Tax Account \$284,394.29; Dresser Traprock \$15,042.52.

#### **CLERK's REPORT**

Carlson reported worked on Liquor License that are being renewed tonight, public record request and looking at a retention schedule to bring forward and working on cleaning up the storage area.

## **OLD BUSINESS**

#### **LRIP GRANT Oak Drive**

The Local Road Improvement Program (LRIP) through the State of Wisconsin Department of Transportation, State Municipal Project funding. The proposed project would be to improve 4,011'x22'

of blacktop on Oak Drive and shoulder the new asphalt to a width of 2'. The Town is to purchase the material for the shouldering directly from Dresser Trap Rock. Everson questioned if trucking would be an additional cost for this traprock. Public Works Supervisor Johnson was not sure, but did not believe there was an additional cost for same type projects in the past. Once the project is completed, the Town will submit invoices to Polk County for reimbursement from the grant funds.

#### **EAGLE BLUFF ROAD**

Eagle Bluff Road is part of Lotus Ridge Estates in the Town of Osceola, approved by the Board in May 2006. On the final plat, the roads in the development that were dedicated to the Town were to be held in public trust by the Town until the conditions that were laid out in the subdivision approval were met. Only then would the Town assume maintenance of the road. In 2007 another developer purchased the subdivision. To date the improvements of the road have not yet been made. The property owners on Eagle Bluff Road have approached the previous Board on several occasions over the past year requesting the Town's help in making the improvements so that the Town would begin maintaining the road, which is in need of repairs.

Supervisor Everson and Gustafson stated that it would set a dangerous precedence for the Town to pay for the improvements of Eagle Bluff Road when the Town does not own the road, nor is it constructed to Town road specifications. Other requests from property owners who live on private roads could ask for the same consideration, costing the Town a considerable amount of money it could not afford. Several months ago the Town Interim Clerk had sent a certified letter to the developer pleading the case of the property owners with hopes that a resolution could be made; however, the developer did not acknowledge the letter. There is little else the Town can do to help the property owners at this point. Wallis stated that he would rather see no action taken by the Board than to take action indicating a negative Board response.

#### **BASIC CYBER SECURITY ASSESSMENT**

At the previous Meeting, the Board expressed their commitment to improve security measures with regard to its ITT services. Easy IT Guys, the Town's current IT support company, presented their proposal for basic cyber security assessment. However, the Board agreed that the Town should seek other proposals from similar companies.

The Board discussed the pro's and con's of establishing business class emails for the Board, rather than have personal email accounts (currently using Gmail). Wisconsin States require Board Members to retain all Town-related documents for 10 years, regardless if they are currently on the Board or not. This has been a challenge in the past with private e-mail accounts. Easy IT Guys submitted a proposal for business e-mail accounts for the Board, staff, and Plan Commission, at a cost that would be reoccurring each year. The Board agreed that other proposals should be sought before making a decision.

One of the liquor establishments is sponsoring outdoor music concerts this summer, a large one in particular the second weekend in September that will draw many people to the site. She expressed concern with parking on Highway 35, traffic congestion in general, and the noise level of the concerts. She will do research and provide an update to the Board in July.

**Neil Gustafson** reported on a road issue that was resolved without further intervention.

Mike Wallis reported that the Audio System was recently hardwired to eliminate the need for batteries.
