Discussion about current / future road projects

- Summer 2024 road projects:
 - 200th Street- GSB-88: cracks have been fixed.
 - 70th Ave- pulverizing / repaving:
 - Gravel lift is completed
 - Pulverizing done
 - Paving late done
 - Shouldering will be completed first part of September
 - 110th Street- pulverizing / repaving:
 - Pulverizing complete
 - Paving complete
 - Stripe, shouldering- next week, crosswalk need to be first part of September
 - o 240th Street- completed
 - 248th Street- completed
 - Chip sealing:
 - Completed 7.4 miles for the Town (worked with other towns for 4 days)
 - Chip sealing oil cost is \$ 2.5 gallon
 - o Spray patching:
 - 1st half started should be completed in 1 week (4.5 miles so far with .5 miles to go.)
 - Oil cost is the same price as last 4,000 gallons for year.
 - Will finish in September (2,000 gallons)
- · Discussion on patching on repairing potholes as needed
- Sand / salt shed is 25% full.
- Starting to mow ditches.
 - Working on second pass on all roads about 30% completed at this time also brushing as needed.
- Culvert on 200th Street
 - Culvert was installed by county on August 13th.
 - Need to wedge opening in road.
- Discussed ARIP grant and using Daniel Fedderly, with DJ Fedderly Management Consultant LLC, to help with preparing 2nd grant.
 - o 60th Ave from 240th street to CTY road M- grant was denied- will resubmit for 2nd round
 - o 218th street from 60th Ave to CTY road M- grant was denied- will resubmit for 2nd round
- Delmore Consultant's will be used for culvert inspection.
 - o Will be in the area to inspect with the next couple of months.
- Parks and Boat Landing
 - o Garbage cans and porta-pottys have been installed at the landing and Town parks.

Location of speed sign 110th ave. Move to 60th ave next week.

Discussion about current Public Works budget:

- One ton truck dump:
 - Look at fixing holes in dump box.
 - Discussion of possible future upgrade of one-ton truck. No update
- Need to replace rear tires on Mack truck in fall of 2024 \$5,000. Getting quote.
- Update on new double axel dump truck.
 - o \$186,076 for basic truck 2025 (\$5,000 deposit on 11-11-2024) Has been built and inspected
 - \$170,755 for box, blades, and sander completion March 2025 from Universal
- Went over current budget and future purchases.
- Considered 5-year road plan budget based on referendum not passing
- Discussion of possible future office build-out for shop. No update.
- Discussion of possible hot water fix of kitchen sink. Consider installing instant hot water device on sink
- Discussion of possible future rental or purchase of smaller payloader. No update
- Update on Simmon Drive. Waiting on construction to start.
